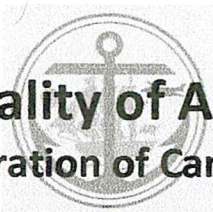


# Municipality of Anchorage Declaration of Candidacy

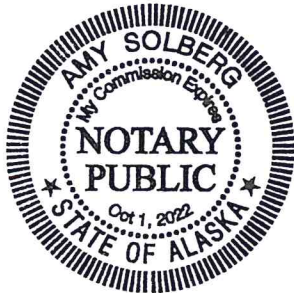
