
- (1) I am a qualified voter of Anchorage;

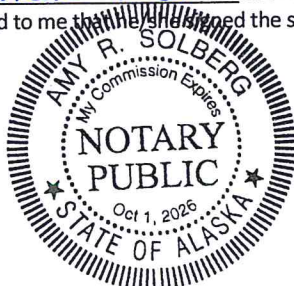


