Ballot Recount

Joe McKinnon filed his request for recount in Section 3 this afternoon, a copy of which is attached.

A review of AS 15.20.480 and AS 29.28.050 and GAAB 7-19 shows no specific direction applicable to the borough for recount procedure, other than that the Assembly shall appoint the recount board rather than designation by the candidates as provided in Title 15.

A resolution is presented directing the Clerk to conduct the recount and extending appointment of the same boards who served on the 2nd of October. From this pool we will assign judges who can be available next Wednesday, as many as are required to manually count the ballots cited.

Since only the Assembly ballot need be recounted, it would appear that one board of 4 persons can count the two initial precincts in very short order.

As for procedure, recommendation is that the same counting methods be followed as used at a paper ballot election, the Clerk to provide tally sheets and whatever other materials are required. Mr. Graham and Mr. McKinnon would be invited to designate 3 people each, one to watch each tally clerk and one to watch the reader. If the candidate wishes to watch at this close range also, he would have to be one of the three.

None of the watchers may handle ballots or interfere in any way with the count except to halt the procedure if one feels that an error has been made. The ballots will be counted in batches of ten or twenty with the clerks changing colors as they mark tally at the end of each batch. If an error is alleged, the count will be backed up only to the last change of color.

All watchers must present identification signed by the candidate they represent and when the count is completed all must sign an affidavit relative to the outcome.

Mr. McKinnon has posted a deposit of \$100.00, based on the rate set per precinct in state election recounts. Only actual costs for the judges who make the recount will be charged and any excess will be refunded. If the recount changes the outcome of the election, the borough must bear the cost.

Your approval of this procedure is specifically requested.
