"Ownership change" means: (1) If the licensee is a partnership, including a limited partnership, any change in the identity of the partners, or in the ownership percentages held by any partners; (2) If the licensee is a limited liability company, any change in the identity of the members or managers, or in the ownership percentage held by any member; or (3) If the licensee is a corporation, any change in its corporate officers, any sale of corporate stock to a person not currently an owner, or any change of the percentage ownership of an existing shareholder.*

\_\_\_\_\_ (initial) I understand that if this application for a transfer is submitted after April 30 and before July 1, the establishment must also submit a Renewal Application for Municipal Marijuana Establishment License.
