

Municipal Boards and Commissions

Purpose: Listed below are the currently active municipal boards and commissions in alphabetical order, excluding service area supervisory boards. This document provides a snapshot of all active boards and commissions, as well as documenting boards that have been recently repealed or sunsetted, and references to the Charter (if applicable) and municipal code.

Charter § 5.07, Boards and Commissions, sets out requirements to establish advisory, regulatory, appellate or quasi-judicial boards or commissions, and the powers of appointment of members by the Mayor and confirmation of each by the Assembly. A few boards or commissions are required by the Home Rule Charter, some have unique features.

Background: Shortly after unification creating the Municipality, several boards and commissions from the City of Anchorage and the Greater Anchorage Area Borough re-established within the new local government through AO 77-76; new AMC Title 4 was adopted with a few additional commissions added in AO 77-299.

While board members are generally volunteers who serve without compensation (with a few exceptions), each entity incurs municipal costs for staffing, meeting site planning, equipment and logistics, and overhead. A sunset (termination) and reauthorization system was created in the 2000s to ensure close, regular Assembly oversight of the efficacy and necessity of each.

How boards work: With a few exceptions, all boards and commissions are listed in Title 4 of the Anchorage Municipal Code. Chapter 4.05 contains rules and procedures that govern boards and commissions, unless otherwise provided in a specific ordinance: three-year terms for members, with removal only for cause, and automatic sunset of most entities every three years in October, unless reauthorized by Assembly action. For each board or commission's specific purpose, function and duties, refer to the referenced code section or the original enabling ordinance.

How the sunset process works: For the year in which a board is scheduled to sunset, the Municipal Office of Internal Audit produces a sunset audit report for each one, as part of the annual audit plan. In June, the Clerk's Office introduces an ordinance through the chair listing each board and commission scheduled to sunset in October, with a public hearing set for the first regular Assembly meeting in October, to allow for action prior to the sunset date of October 14.

Certain boards and commissions are not subject to the automatic sunset: boards required by the Charter, boards that have a utility or public corporate governance function, and boards that have regulatory and adjudicatory functions.
