- *Friday*: work sessions, potentially special meetings; 1/mo is “No Meeting Friday”
- *1st Weds of month*: no standing committee meetings; fair game scheduling for work sessions and special meetings, if needed.
- *4th week of month*: no standing committee meetings; may require work sessions and may fall during regular Tuesday meeting
- Proposed frequency
 - **Monthly**: Budget, Governance, Safety, Ent & Util, Housing & CD, AMATS
 - **Other**: Transpo (bi-monthly), Health (bi-monthly), Audit (bi-monthly + special as needed), Legislative (monthly to develop Leg Program, during state session)
