### ANCHORAGE, ALASKA AO NO. 2025–77

AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY TO REAUTHORIZE CERTAIN BOARDS AND COMMISSIONS BY AMENDING THE SUNSET PROVISIONS IN ANCHORAGE MUNICIPAL CODE SECTIONS 4.40.125, 4.40.150, 4.60.150, 4.60.210, 4.60.240, AND 4.60.260.

**WHEREAS,** AO 2011-64(S-1), *As Amended,* revived sunset provisions for boards and commissions, and created a process for advance notice and internal audit of boards and commissions prior to sunset; and

**WHEREAS**, Section 14 of AO 2011-64(S-1), *As Amended*, calls for advance introduction of an ordinance for reauthorization, with an Assembly Memorandum confirming direction to the Office of Internal Audit to conduct the audits of these boards and commissions; and

**WHEREAS**, six (6) boards and commissions have the sunset date of October 14, 2025 indicated in the Anchorage Municipal Code; and

**WHEREAS**, the Internal Auditor will report findings to the Mayor and Assembly at least 60 days prior to the sunset date of October 14, 2025, to allow time for a public hearing and review prior to action by the Assembly on reauthorization; now therefore,

#### THE ANCHORAGE ASSEMBLY ORDAINS:
