A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FUND BALANCE IN AN AMOUNT NOT TO EXCEED EIGHT MILLION TWO HUNDRED FIFTY THOUSAND DOLLARS (\$8,250,000) TO CONTINUE PROGRAMS APPROVED IN THE PRIORITY AREAS AND FRAMEWORK FOR ALLOCATION OF THE COVID-19 RELIEF FUNDS PROGRAMS.

This resolution proposes using Areawide General Fund (101000) Fund Balance in an amount not to exceed \$8,250,000 to provide economic stabilization in the community in response to the COVID-19 pandemic, by continuing approved programs, as follows:

- \$500,000 Risk Pool Insurance Program for Private Landlords.
- \$550,000 Utility Service.
- \$200,000 Anchorage Health Department. For additional Public Health Nurses, an Epidemiologist, and Homelessness Program Support personnel and includes amount for Assembly mental health first responder.
- \$6,400,000 Rental & Mortgage Assistance. For further relief to residents impacted by COVID-19. There is a demonstrated need for additional funding for this program as we have made over 11,000 housing payments, expending over \$10 million to date. We expect the current funding already appropriated by the Assembly to last throughout December; this new funding would allow the program to continue into 2021. Accounting adjustment from 2020 to 2021.
- \$600,000 AKHR Meals Program. United Way AKHR C.A.R.E.S Meals Program. This program is a partnership between the Alaska Hospitality Retailers, United Way, and the MOA. The program was started with money received by United Way from the Coronavirus Nonprofit Relief Grants fund. Food service businesses receive funds each week to prepare meals for organizations that provide food to low-income families and individuals struggling to make ends meet. This additional funding would allow the program to continue beyond 2020. Accounting adjustment from 2020 to 2021.
