BB 9110 SCHOOL BOARD MEMBERSHIP

Regular Members

The School Board shall consist of seven members elected or appointed in accordance with law.

Military Delegate

The School Board shall appoint a delegate from the military community to serve on the School Board in a nonvoting capacity. The delegate receives non-confidential School Board materials, attends public sessions of the School Board, and advises the School Board relating to the management and control of military schools.

Student School Board Member

The School Board believes it is important to seek out and consider students' ideas, viewpoints and reactions to the educational program. In order to provide student input and involvement, the School Board shall appoint a student School Board member as deemed necessary.

The Student School Board member shall have the right to attend public meetings of the School Board, be recognized at meetings, participate in questioning witnesses and discussing issues and shall receive all materials presented to School Board members except those related to executive sessions.

Student School Board members may cast preferential votes on all matters except those subject to executive session discussion. Preferential votes shall be cast prior to the official School Board vote and shall not affect the outcome of a vote. Preferential votes shall be recorded in the School Board minutes.
