# 30 Days

#### Focus

Assess the MOA's equity-related efforts

### Priorities

- 1. Inventory equity-related requirements that the MOA is obligated to meet. Answer:
  - a. What is the requirement?
  - b. What is the specific code reference?
  - c. What agency audits the requirement?
  - d. When was the last audit and what was the result?
  - e. Who at the MOA is responsible for reporting on the requirement?
  - f. What is the current status regarding meeting the requirement?
  - g. What department(s) are accountable for actions related to meeting the requirement?
  - h. What sources of funding are at risk for non-compliance and how might that impact the MOA?
- 2. Inventory equity-related projects that the MOA community has recently or is currently undertaking.

  Answer:
  - a. What is the project?
  - b. Is there a specific ask of the MOA?
  - c. Has this ask been addressed?
- 3. Inventory data points that can be utilized to produce an interactive GIS map that would allow the MOA and community to analyze equity-related indicators by census-block.

- 2. Database of community-related projects
- 3. List of potential datapoints

## **Priorities**

  - d. Administrative practice recommendations
- 2. For MOA requirements that are being met but have room for improvement to make the MOA a national leader, propose actions including but not limited to:
  - a. Policy & Procedure enhancements

- b. MOA Code enhancements
- c. Classification revisions
- d. Administrative practice recommendations
- 3. Determine means of implementing an Equity Map for the MOA.
  - a. Identify feasible vehicle for implementation
  - b. Organize project team

  - c. Ensure reports are on-schedule to be filed on-time.
  - d. Host community meetings to explain the MOA equity-related reports.
- 2. Implement an Equity Map for the MOA
  - a. Do the work of creating the map
  - b. Publish the map on the MOA website
  - c. Host meetings and trainings on how to use the map
- 3. Continue participation in community-led efforts.
