WHEREAS, the Approved 2022 budget for the Municipality of Anchorage was adopted by AO 2021-96(S), As Amended; and

WHEREAS, the Revised 2022 budget was adopted by AR 2022-98(S), As Amended; and

WHEREAS, ARPA funding for Beetle Kill Mitigation was reappropriated to other projects and should be funded out of the general government operating budget to allow for federal matching; and

WHEREAS, the Municipality is expected to receive additional funds from the State of Alaska Community Assistance Program that will exceed budget by \$5.4 million dollars; and

WHEREAS, the Anchorage Assembly recognizes there are crucial funding needs to repair the Sullivan Arena, cover increased fuel costs, and cover increased towing costs; now, therefore

THE ANCHORAGE ASSEMBLY RESOLVES:

<u>Section 1.</u> That an amount not to exceed THREE HUNDRED THOUSAND DOLLARS (\$300,000) is hereby appropriated to the Anchorage Police Department 2022 operating budget for increased vehicle towing costs.

<u>Section 2.</u> That an amount not to exceed ONE MILLION SEVEN HUNDRED FIFTY THOUSAND DOLLARS (\$1,750,000) is hereby appropriated to the Maintenance & Operations 2022 operating budget for repair work on the Sullivan Arena.

<u>Section 3.</u> That an amount not to exceed TWO MILLION DOLLARS (\$2,000,000) is hereby appropriated to multiple departments' 2022 operating budget for increased fuel costs.

Section 4. That an amount not to exceed ONE MILLION DOLLARS (\$1,000,000) is hereby appropriated to the Anchorage Fire Department 2022 operating budget for Beetle Kill Mitigation.
