1 AN ORDINANCE PROVIDING FINANCIAL RESOURCES FOR LABOR, SUPPLIES,
2 AND OTHER EXPENDITURES IS REQUIRED TO ADDRESS MUNICIPAL
3 RESPONSE TO CORONAVIRUS DISEASE 2019 (COVID-19) BY APPROPRIATING
4 AN AMOUNT NOT TO EXCEED SEVEN MILLION DOLLARS (\$7,000,000) IN
5 INTERFUND LOAN PROCEEDS FROM THE ALCOHOLIC BEVERAGES RETAIL
6 SALES TAX FUND (206000), TO THE COVID-19 RESPONSE AO FUND (231803),
7 AND PROVIDING A PLAN FOR FUTURE REIMBURSEMENT OF SAID
8 APPROPRIATION.

10 WHEREAS, on March 12, 2020, pursuant to authority granted in Article V, Section 5.02
11 of the Home Rule Charter for the Municipality of Anchorage and AMC 3.80.040, the
12 Mayor declared that a civil emergency existed within the Municipality of Anchorage
13 based upon the events and circumstances specified above; and

14
15 WHEREAS, COVID-19 still is impacting the citizens of Anchorage; and

16
17 WHEREAS, The Alcoholic Beverages Retail Sales Tax was approved by the
18 Anchorage voters to be dedicated, in part, to prevent and address Anchorage's
19 homelessness crisis; and

21 WHEREAS, the Municipality is pursuing State and Federal assistance that, if and to
22 the extent received, will be used to fully reimburse the costs of protecting the public
23 safety, health, and welfare of the Municipality of Anchorage from COVID-19; now,
24 therefore,

26 THE ANCHORAGE ASSEMBLY ORDAINS:

27
28 Section 1. That an amount of not to exceed SEVEN MILLION DOLLARS
29 (\$7,000,000) in Interfund Loan proceeds from the Alcoholic Beverages Retail Sales
30 Tax Fund (206000) General Cash Pool Equity, is hereby appropriated to the COVID-
31 19 Response AO Fund (231803) for labor, supplies, professional services, mass care,
32 and other expenses required to preserve and protect the public safety, health and
33 welfare from COVID-19 for an estimated period of performance of April 1, 2022,
34 through June 30, 2022.

35
36 Section 2. The Municipality's Chief Fiscal Officer is delegated the responsibility to
37 pursue reimbursement of costs from all available State of Alaska and Federal
38 assistance programs.

40 Section 3. This ordinance shall take effect immediately upon passage and approval
41 by the Anchorage Assembly.
