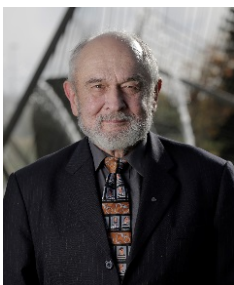

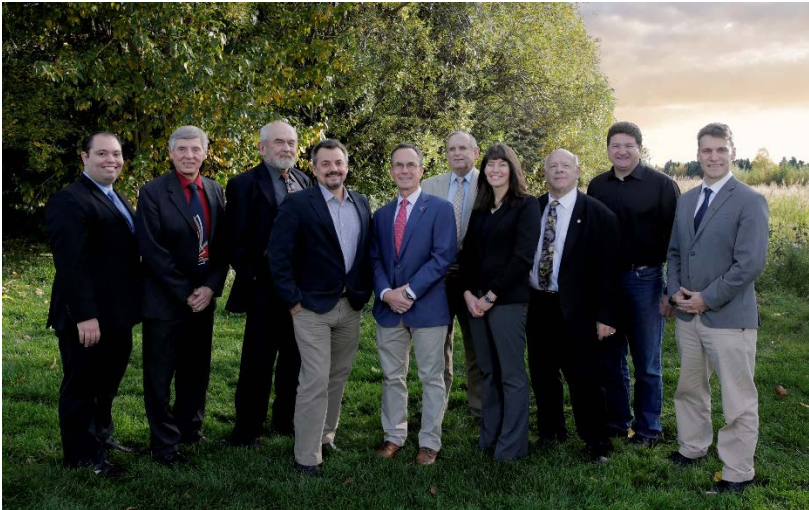


In 1975, the City of Anchorage and the Greater Anchorage Area Borough unified and together became known as the Municipality of Anchorage. The Municipality of Anchorage derives its power from its 1975 Home Rule Charter and operates under the Anchorage Municipal Code and the Anchorage Municipal Code of Regulations, and the Constitution of the State of Alaska and its laws. Alaska Statute Title 29 establishes the policy of maximum local self-government and as a home rule municipality, the legislative power of the Municipality is vested in the Anchorage Assembly, an eleven-member body elected by the voters of the Municipality of Anchorage.

The Assembly meets at least twice each month to conduct regular business on Tuesdays beginning at 5:00 p.m. in the Assembly Chambers, located at the Z.J. Loussac Library, 3600 Denali Street, Anchorage, AK 99503. The Assembly meeting schedule is published on the Assembly webpage at www.muni.org/Assembly. All meetings of the Assembly are open to the public and broadcast Live on Channel 9. Copies of the Regular Assembly Meeting agendas and items under consideration are provided at each meeting and on-line at www.muni.org/watchnow.
