WEST ANCHORAGE VOTERS: REMINDER TO REGISTER TO VOTE BY JULY 8, 2018

The Municipal Clerk's Office reminds voters in West Anchorage Assembly District 3 to register to vote or to update their voter registration with the State of Alaska on or before July 8, 2018 in order for these changes to be effective for the August 7 Special Municipal Election.

Register to Vote. Any qualified Alaskan resident at least seventeen years and nine months old may register to vote. In order to vote in the August 7 Special Municipal Election you must be:

1. A District 3 resident at least 30 days prior to August 7, and
2. At least eighteen years old on or before August 7, 2018.

Voters may find their Assembly District by entering their residence address on the interactive Assembly District Map at muni.org/AssemblyDistrictMap or they may call the Voter Hotline at 243-VOTE (8683). A voter registration application is online at <https://voterregistration.alaska.gov/> or may be picked up at the MOA Election Center at 619 East Ship Creek Avenue, Door D or the Municipal Clerk's Office at 632 West 6th Avenue, Suite 250, during normal business hours. For more information about registering to vote, call the Alaska Division of Elections at 907-522-8683.

Update your Voter Registration. If your voter information has changed since you last voted, you must update your information with the State of Alaska Division of Elections by July 8 2018 in order for these changes to be effective for the August 7 Special Municipal Election. To update your voter registration, the application is online at <https://voterregistration.alaska.gov/> or you may update your registration at the MOA Election Center at 619 East Ship Creek Avenue, Door D or the Municipal Clerk's Office at 632 West 6th Avenue, Suite 250, during normal business hours. For more information about updating your voter information, call the Alaska Division of Elections at 907-522-8683.

Voting at a Temporary Address. If you will be traveling and want to receive your ballot package at a temporary address rather than your regular mailing address, complete the Application to Vote at a Temporary Address at muni.org/tempapp, or call the Voter Hotline at 907-243-VOTE (8683) for more information.

August 7, 2018 Special Municipal Election is by mail! The Municipal Clerk's Office reminds West Anchorage voters that traditional polling locations will not be an option for voting on Election Day, August 7, 2018. Instead, ballot packages will be mailed to qualified, registered voters in West Anchorage Assembly District 3 on July 17, 2018 - three weeks before Election Day. Voters will have the opportunity to study the ballot with trusted resources, mark their choices, sign the voter declaration, and return their ballot by Secure Drop Box, Accessible Vote Center (AVC), or by mailing through the USPS. For this special election, the Accessible Vote Center will be at the MOA Election Center at 619 East Ship Creek Avenue at Door D. Information on Secure Drop Box locations coming soon.
