Α RESOLUTION OF THE MUNICIPALITY OF **ANCHORAGE** REAPPROPRIATING TWO HUNDRED SEVENTY-SEVEN THOUSAND, FIVE HUNDRED DOLLARS (\$277,500) FOR SETTLEMENT OF CLAIMS AGAINST THE MUNICIPALITY OF ANCHORAGE, PREVIOUSLY APPROPRIATED BY AR 2023-102(S), AS AMENDED, FOR THE SETTLEMENT OF CLAIMS SPECIFIC LEGAL **EXCLUDING** THREE CLAIMS AGAINST MUNICIPALITY, ALL WITHIN THE 2023 OPERATING BUDGET, AREAWIDE GENERAL FUND (101000). WHEREAS, The Anchorage Assembly approved on April 25, 2023, AR 2023-102(S), As Amended which contained an appropriation of \$827,500 for the settlement of legal claims against the Municipality of Anchorage; and WHEREAS, Pursuant to a floor amendment, the Assembly specificized this appropriation was not for the settlement of claims brought against the Municipality of Anchorage by Ms. Amy Demboski, Ms. Heather MacAlpine, or Roger Hickel Contracting absent a specific subsequent appropriation; and WHEREAS, On May 5, 2023, the Assembly met in executive session to be briefed the Department of Law on the pending settlement of those claims; WHEREAS, the Assembly held a public hearing on AR 2023-162 at its May 23, 2023 regular meeting, and considered AR 2023-162(S) which reduced the appropriation to only be available for claims asserted by Ms. Demboski, and now desires to appropriate separately by this resolution for settlement of claims asserted by Ms. MacAlpine; now therefore THE ANCHORAGE ASSEMBLY RESOLVES: Section 1. That an amount not to exceed Two Hundred Seventy-Seven Thousand, Five Hundred Dollars (\$277,500) is hereby reappropriated within the 2023 Operating Budget, Areawide General Fund (101000) to provide for payments in settlement of any legal claims against the Municipality of Anchorage asserted by Ms. Heather MacAlpine. **Section 2.** That this resolution shall take effect upon approval by the Anchorage Municipal Assembly.
