**Subject:** A request to rezone approximately 8,860 acres of land owned by MOA from R-1,

R-2A, R-2ASL, R-2D, R-2M, R-2MSL, R-3, R-3SL, R-4, R-5, R-6, R-7, R-8, R-9, R-10SL, B-2A, B-2C, B3, B-3SL, I-1, I-2, PCD, PLI, PLI-P and PLISL to Parks and

Recreation District (PR) zoning

The Planning Department is seeking comments on the attached draft ordinance to rezone approximately 8,860 acres of public land used for parks across the Anchorage Bowl to Parks and Recreation District (PR) zoning.

The 2040 Land Use Plan designates these areas as parks and open space. Action 8-4 of the 2040 Land Use Plan states: "Conduct housekeeping rezone of dedicated parks to PR district, and some T-zoned lands to PLI." Staff welcomes any comments on this ordinance and, depending on the volume of feedback received, may provide an amended draft for review by the Planning and Zoning Commission.

Your comments will be submitted to the Planning and Zoning Commission for a public hearing scheduled for Monday, December 8, 2025, at 6:30 p.m. in the Assembly Chambers of the Z.J. Loussac Library, 3600 Denali Street, Anchorage. Recommendations from the Commission will be forwarded to the Assembly.



### ANCHORAGE, ALASKA AO No. 2025-\_\_\_

AN ORDINANCE AMENDING THE ZONING MAP AND APPROVING THE REZONE FOR 12 PARCELS OF CONTAINING APPROXIMATELY 8,860.4 ACRES FROM R-1, R-2A, R-2ASL, R-2D, R-2M, R-2MSL, R-3, R-3SL, R-4, R-5, R-6, R-7, R-8, R-9, R-10SL, B-2A, B-2C, B3, B-3SL, I-1, I-2, PCD, PLI, PLI-P AND PLISL TO THE PROPRIED IN EXHIBIT A.

**WHEREAS,** AO 2025-40(S) provided the Municipality with more tools for initiating and facilitating rezones; and

**WHEREAS,** AMC 21.04.060, the PR district is intended to include municipal lands dedicated by the Assembly as parks in accordance with AMC 25.10.080; and

**WHEREAS**, Action 8-4 of the Anchorage 2040 Land Use Plan states "Conduct housekeeping rezone of dedicated parks to PR district, and some T-zoned lands to PLI"; and

**WHEREAS**, the Planning Department has prepared this ordinance to incorporate those changes and bring them through the standard Planning and Zoning Commission process; now, therefore,

#### THE ANCHORAGE ASSEMBLY ORDAINS:

**Section 1.** The zoning map shall be amended by designating the properties drawn in Exhibit A as PR:

<u>Section 2.</u> The Director of the Planning Department shall change the zoning map accordingly.

**Section 3.** The ordinance shall become effective immediately upon passage and approval by the Assembly.
