Need for Expansion

- Current facilities and infrastructure are not designed or sufficient for year-round operations
 - Overcrowded staff space (codes)
- No fire suppression
 - Prevents additional structures of any size
- Temporary tents and shelters
- Parking lot fills for events no overflow option



Expansion Plan

2024 – Agnew::Beck conducted a feasibility study for expansion options

- Demonstrates that ABG can operate an expansion of either size
- \$10M Education Center (smaller facility)
- \$16M Visitor Center (larger, maximizes rentals)

 - Would double local memberships & tourist visits
- Education Center 7,000 sqft, limited programs + rentals

 - Would double local membership & tourist visits
- Visitor Center 12,000 sqft, full programs + rentals




