### 3. PLEDGE OF ALLEGIANCE AND LAND ACKNOWLEDGMENT

Hundred Seventeen Thousand Dollars (\$1,217,000) previously appropriated for Adult Emergency Sheltering and the appropriation of Not To Exceed One Million Two Hundred Sixteen Thousand Dollars (\$1,216,000) of Alcoholic Beverages Retails Sales Tax Fund (206000) Fund Balance to the Anchorage Health Department to be used for Emergency Cold Weather Sheltering, both as approved in AR 2022-293, As Amended; and appropriating an amount Not To Exceed One Million One Hundred and Two Thousand Five Hundred Dollars (\$1,102,500) of Alcoholic Beverages Retails Sales Tax Fund (206000) Fund Balance to the Anchorage Health Department to be used for Emergency Sheltering, Assembly Vice-Chair Constant and Assembly Member Rivera. (Laid-on-the-Table)
