- Complete the **Transit Supported Development** project
- Support Administration in the Title 23 **Building Code updates**, a pro-housing **Comp Plan update**, developing **public lands for housing**, and addressing **vacant, abandoned buildings**
- Strengthen long-term partnerships to **sustain and improve the shelter system**

2026 PROGRESS REPORT

2025 Accomplishments continued

HOUSING ACTION

Committees: CEDC & Housing & Homelessness

- **Cut red tape and improved incentives to build multi-family housing:** updated B-3 mixed use zone, paused multi-family residential design standards, increased tax incentives for 8+ unit and renovations of vacant/abandoned housing, began zoning update in Transit-Supportive Development Corridors
- **Made it easier to renovate and rehabilitate existing housing:** eased zoning conformity requirements for older buildings, updated Site Access standards, vacated/cleared abandoned properties
- **Created more flexibility and access to new types of housing:** updated requirements for relocatable dwelling units (manufactured/mobile homes) and created pre-approved design program for ADUs
- **Explored options for opening up more land to housing development:** ASD transfer of Totem Theater land to MOA for housing, pursued housing projects on National Archives site and HLB lands
- **Increased protections for renters:** increased enforcement and fines on dangerous residential buildings
- Extended 3rd party planning review for commercial construction

HOMELESSNESS

Committees: Housing & Homelessness

- Hosted a **community Summit on Anchorage's response to homelessness**
- **Restricted illegal camping** in parks & public lands
- Monitored implementation of **MOA year-round shelter system and opening of East 5th Ave shelter**, significantly improving system stability
- Passed ordinances to **give more flexibility with tiny homes and temporary shelters**
- **Increased treatment bed capacity**, including 24 tiny homes with the recovery pilot project
- Expanded and improved scale and effectiveness of **street outreach**
- **Improved coordination among service providers**, funders & municipal departments
- **Increased overall system effectiveness**, contributing to fewer people camping and better connections to shelter and services

ASSEMBLY BUSINESS

Committees: Rules, Ethics & Elections

- **Onboarded four new members**
- **Strengthened Youth Representative Program**
- **Supported election reform efforts** in State Legislature
- **Secured four of the MOA requests to the legislature:** BSA increase, funding for wildfire prevention, Chugach State Park access bill and \$10M for statewide behavioral health services
- **Provided Local Government 101 training** to 160+ youth and adults
- **Engaged thousands of residents in community discussions** through Town Halls, fiscal future workshops, City Nerd Nites and MOA 50th Anniversary events
- Pursued creation of a Civic Anchor project to **engage more residents in local government**

2025 ACCOMPLISHMENTS

GOOD GOVERNMENT

Committees: Budget & Finance, Quality MOA Services

- Increased public **outreach/education on MOA budget** and launched a fiscal future workshop
- **Celebrated the 50th Anniversary of the Municipality** with events, stories and activities
- Supported 2nd annual **MOA workforce survey**
- **Researched Rank Choice Voting option** for Municipal elections, but could not find a path
- **Robust review of FY26 budget** to identify budget-neutral cost reductions to make room for other priorities
- **Purchased City Hall** to stabilize costs

PUBLIC HEALTH, SAFETY & QUALITY OF LIFE

Committees: Public Health & Safety

- Permanently established **free fares for youth under 18 on People Mover**; added additional free day for senior citizens
- Facilitated task force to develop new **approach to community involvement in public safety**
- Implemented **significant APD technology upgrades & expanded camera partnerships** to enhance public safety and investigations
- **Strengthened crisis intervention and response and integration of services** across MCT, MMI, HOPE Team, APD, and Community Service Officers (IMPACT Team)
- Adopted a **fire ban ordinance**
- Continued monitoring creation of **Alaska Center for Treatment**
- Advanced accountability and trust through **multiple independent evaluations of APD**

ECONOMIC DEVELOPMENT

Committees: CEDC, IEUOC

- Approved **Girdwood Comprehensive Plan**; identified funding for **Chugiak-Eagle River Plan**
- Engaged the community in **discussions on new tax revenue options**
- **Supported small businesses:** reduced inventory tax, new tax incentives for farmlands, updated Cottage Food code, funded child care and early education through marijuana tax revenue
- Provided policy direction on **ways to maximize use of bed tax revenues**

INFRASTRUCTURE & TRANSPORTATION

Committees: IEUOC, Transportation

- Continued to pursue **full restoration of Eklutna River** and **Pumped Storage Hydro options**
- **Oversaw major progress on Port of Alaska Modernization:** awarded Terminal 1 construction contract, authorized bonds for construction of Terminals 1 and 2, monitored the crane agreement
- Continued to work with Administration on future of **Chugach State Park Access (CASA) bond program**
- **Monitored development of waste to energy project**, solar on MOA roofs & vehicles, and advocated to legislature to address natural gas shortage
- **Adopted a long-range transportation strategy** as an element of the comprehensive plan
- Confirmed **Stormwater Utility appointments**
