AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE MOUNTAIN PARK ESTATES LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 21, 1998 A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS AND AMENDING ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.250 AND 27.30.330.

WHEREAS THE Mountain Park Estates Limited Road Service Area was created by Anchorage Ordinance 83-57; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 1998 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Mountain Park Estates Limited Road Service Area at the regular Municipal election on April 21, 1998:

CONTINUATION OF THE  
MOUNTAIN PARK ESTATES LIMITED ROAD SERVICE AREA

Shall the existence of the Mountain Park Estates Limited Road Service area be continued for an additional period of three (3) years after December 31, 1998 until December 31, 2001?

1 Section 2. That Section 27.20.250 of the Anchorage Municipal  
2 Code is hereby amended to read as follows:  
3

4 Pursuant to section 27.10.050, there is established a  
5 board of supervisors to administer the Mountain Park Estates  
6 Limited Road Service Area. The board shall consist of three  
7 members appointed by the mayor and confirmed by the Assembly  
8 to administer the service area until the regular election of  
9 October 1984, at which time the supervisors will be elected  
10 for staggered terms. Initial terms of supervisors elected at  
11 the regular election of October 1984 shall be selected by lot.  
12 [THE SERVICE AREA WILL EXPIRE ON DECEMBER 31, 1998, UNLESS IT  
13 IS EXTENDED BY VOTE IN THE AREA AFFECTED AT THE REGULAR  
14 ELECTION OF APRIL 1998.]  
15

16 Section 3. That Section 27.30.330 of the Anchorage Municipal  
17 Code is hereby amended to read as follows:  
18

19 There is a limited road service area within the  
20 municipality known as the Mountain Park Estates Limited Road  
21 Service Area to provide limited road maintenance and repair to  
22 the area described on the map located in section 27.30.700.  
23

24 Limited road maintenance and repair within the service  
25 area shall commence on January 1, 1984, and shall end on  
26 December 31, [1998] 2001, unless the service area is extended  
27 by an affirmative vote in the service area [AFFECTED] at the  
28 regular election of April [1998] 2001. The mill rate shall  
29 not exceed 1.0 mill in any calendar year.  
30

32 Section 4. Except for Section 3, this ordinance shall become  
33 effective upon passage and approval. Section 3 and the  
34 proposition contained in Section 1 shall become effective upon  
35 certification of the regular election on the proposition  
36 called for by this ordinance, but only if that proposition is  
37 approved by a majority of the qualified voters voting on the  
38 proposition.
