AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE MOUNTAIN PARK/ROBIN HILL LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 21, 1998 A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS AND AMENDING ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.280 AND 27.30.360.

WHEREAS the Mountain Park/Robin Hill Limited Road Service Area was created by Anchorage Ordinance 83-116 (Anchorage Municipal Code section 27.30.360); and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 1998 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Mountain Park/Robin Hill Limited Road Service Area at the regular Municipal election on April 21, 1998:

CONTINUATION OF THE
MOUNTAIN PARK/ROBIN HILL LIMITED ROAD SERVICE AREA

Shall the existence of the Mountain Park/Robin Hill Limited Road Service area be continued for an additional period of three (3) years after December 31, 1998 until December 31, 2001?

2 Section 2. That Section 27.20.280 of the Anchorage Municipal
3 Code is hereby amended to read as follows:
4

5 Pursuant to section 27.10.050, there is established a
6 board of supervisors to administer the Mountain Park/Robin
7 Hill Limited Road Service Area. The board shall consist of
8 six members appointed by the mayor and confirmed by the
9 Assembly to administer the service area until the regular
10 election of October, 1984, at which time the supervisors will
11 be elected for staggered terms. At least one member shall
12 reside in the Sun Valley Heights area. Initial terms of
13 supervisors elected at the regular election of October, 1984
14 shall be selected by lot. [THE SERVICE AREA WILL EXPIRE ON
15 DECEMBER 31, 1998, UNLESS IT IS EXTENDED BY VOTE IN THE AREA
16 AFFECTED AT THE REGULAR ELECTION OF APRIL 1998.]

18 Section 3. That Section 27.30.360 of the Anchorage Municipal
19 Code is hereby amended to read as follows:

21 There is a limited road service area within the
22 municipality known as the Mountain Park/Robin Hill Limited
23 Road Service Area to provide limited road maintenance and
24 repair to the area described on the map located in section
25 27.30.700.
26

27 Limited road maintenance and repair within the service
28 area shall commence on January 1, 1984, and shall end on
29 December 31, [1998] 2001, unless the service area is extended
30 by an affirmative vote of the service area [AFFECTED] at the
31 regular election of April [1998] 2001. The mill rate shall
32 not exceed 1.3 mills in any calendar year.
33

34 Section 4. Except for Section 3, this ordinance shall become
35 effective upon passage and approval. Section 3 and the
36 proposition contained in Section 1 shall become effective upon
37 certification of the regular election on the proposition
38 called for by this ordinance, but only if that proposition is
39 approved by a majority of the qualified voters voting on the
40 proposition.
