AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE RABBIT CREEK VIEW AND RABBIT CREEK HEIGHTS LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 21, 1998 A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS AND AMENDING ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.160 AND 27.30.240.

WHEREAS THE Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area was created by Anchorage Ordinance 80-134; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 1998 has been made by persons residing in said limited road service area; now therefore,

## THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1.</u> That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area at the regular Municipal election on April 21, 1998:

## CONTINUATION OF THE RABBIT CREEK VIEW AND RABBIT CREEK HEIGHTS LIMITED ROAD SERVICE AREA

Shall the existence of the Rabbit Creek View and Rabbit Creek Heights Limited Road Service area be continued for an additional period of three (3) years after December 31, 1998 until December 31, 2001?

Section 2. That Section 27.20.160 of the Anchorage Municipal Code is hereby amended to read as follows:

There is established a board of supervisors to administer, pursuant to section 27.10.050, the Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area, consisting of three members who shall be elected for staggered terms of one, two and three years. Two members shall constitute a quorum. In the event of a vacancy, the mayor shall appoint a qualified area resident, with confirmation by the Assembly, to serve until the next regular election. **THE** SERVICE AREA BOARD OF SUPERVISORS WILL EXPIRE ON DECEMBER 31, 1998, UNLESS THE SERVICE AREA IS EXTENDED BY AN AFFIRMATIVE VOTE IN THE AREA AFFECTED AT THE REGULAR ELECTION OF APRIL 1998.1

Section 3. That Section 27.30.240 of the Anchorage Municipal Code is hereby amended to read as follows:

There is established a limited road service area within the Municipality of Anchorage known as the Rabbit Creek View and Rabbit Creek Heights Limited Road Service Area to provide for limited road maintenance and repair to the area described on the map located in section 27.30.700. Limited road maintenance and repair within the service area shall commence on January 1, 1981, and end on December 31, [1998] 2001, unless the service area is extended by an affirmative vote in the **service** area [AFFECTED] at the regular election of April [1998] 2001. The mill rate shall not exceed 2.5 mills in any calendar year.

Section 4. Except for Section 3, this ordinance shall become effective upon passage and approval. Section 3 and the proposition contained in Section 1 shall become effective upon certification of the regular election on the proposition called for by this ordinance, but only if that proposition is approved by a majority of the qualified voters voting on the proposition.
