AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE RAVEN WOODS/BUBBLING BROOK LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 21, 1998 A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS AND AMENDING ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.270 AND 27.30.350.

WHEREAS THE Raven Woods/Bubbling Brook Limited Road Service Area was created by Anchorage Ordinance 83-112; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 1998 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Raven Woods/Bubbling Brook Limited Road Service Area at the regular Municipal election on April 21, 1998:

CONTINUATION OF THE
RAVEN WOODS/BUBBLING BROOK LIMITED ROAD SERVICE AREA

Shall the existence of the Raven Woods/Bubbling Brook Limited Road Service area be continued for an additional period of three (3) years after December 31, 1998 until December 31, 2001?

2 Section 2. That Section 27.20.270 of the Anchorage Municipal
3 Code is hereby amended to read as follows:
4

5 Pursuant to section 27.10.050, there is established a
6 board of supervisors to administer the Raven Woods/Bubbling
7 Brook Limited Road Service Area. The board shall consist of
8 three members appointed by the mayor and confirmed by the
9 Assembly to administer the service area until the regular
10 election of October 1984, at which time the supervisors will
11 be elected for staggered terms. Initial terms of supervisors
12 elected at the regular election of October 1984 shall be
13 selected by lot. [THE SERVICE AREA WILL EXPIRE ON DECEMBER
14 31, 1998, UNLESS IT IS EXTENDED BY VOTE IN THE AREA AFFECTED
15 AT THE REGULAR ELECTION OF APRIL 1998.]

17 Section 3. That Section 27.30.350 of the Anchorage Municipal
18 Code is hereby amended to read as follows:
19

20 There is a limited road service area within the
21 municipality known as the Raven Woods/Bubbling Brook Limited
22 Road Service Area to provide limited road maintenance and
23 repair to the area described on the map located in section
24 27.30.700.
25

26 Limited road maintenance and repair within the service
27 area shall commence on January 1, 1984, and shall end on
28 December 31, [1998] 2001, unless the service area is extended
29 by an affirmative vote of the service area [AFFECTED] at the
30 regular election of April [1998] 2001. The mill rate shall
31 not exceed 1.0 mill in any calendar year except that the mill
32 levy for the tax year 1995 shall be increased to 1.5 mills.
33

34 Section 4. Except for Section 3, this ordinance shall become
35 effective upon passage and approval. Section 3 and the
36 proposition contained in Section 1 shall become effective upon
37 certification of the regular election on the proposition
38 called for by this ordinance, but only if that proposition is
39 approved by a majority of the qualified voters voting on the
40 proposition.
