AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE ROCKHILL LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 21, 1998 A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS. ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.320 AND 27.30.590.

WHEREAS THE Rockhill Limited Road Service Area was created by Anchorage Ordinance 89-92; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 1998 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1.</u> That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Rockhill Limited Road Service Area at the regular Municipal election on April 21, 1998:

CONTINUATION OF THE ROCKHILL LIMITED ROAD SERVICE AREA

Shall the existence of the Rockhill Limited Road Service area be continued for an additional period of three (3) years after December 31, 1998 until December 31, 2001?

Section 2. That Section 27.20.320 of the Anchorage Municipal Code is hereby amended to read as follows:

Pursuant to section 27.10.050, there is established a board of supervisors to administer the Rockhill Limited Road Service Area (RLRSA). The board shall consist of three members appointed by the mayor and confirmed by the Assembly to administer the service area until the regular election of October 1990, at which time the supervisors will be elected for staggered terms. Initial terms of supervisors elected at the regular election of October 1990 shall be elected by lot. [THE SERVICE AREA WILL EXPIRE ON DECEMBER 31, 1998, UNLESS IT IS EXTENDED BY VOTE IN THE AREA AFFECTED AT THE REGULAR ELECTION OF APRIL 1998.]

Section 3. That Section 27.30.590 of the Anchorage Municipal Code is hereby amended to read as follows:

There is established, pursuant to Section 9.01 of the Charter, a limited road service area within the municipality to be the Rockhill Limited Road Service Area of the municipality, as outlined on the map located in section 27.30.700.

The Rockhill Limited Road Service Area shall contribute funds expressly for the maintenance of roads commencing January 1, 1990, and shall end on December 31, [1998] 2001, unless the service area is extended by an affirmative vote of the **service** area [AFFECTED] at the regular election of April [1998] 2001. The mill rate shall not exceed 1.50 mills in any calendar year.

<u>Section 4</u>. Except for Section 3, this ordinance shall become effective upon passage and approval. Section 3 and the proposition contained in Section 1 shall become effective upon certification of the regular election on the proposition called for by this ordinance, but only if that proposition is approved by a majority of the qualified voters voting on the proposition.
