AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE ROCKHILL LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 21, 1998 A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS. ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.320 AND 27.30.590.

WHEREAS THE Rockhill Limited Road Service Area was created by Anchorage Ordinance 89-92; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 1998 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Rockhill Limited Road Service Area at the regular Municipal election on April 21, 1998:

CONTINUATION OF THE  
ROCKHILL LIMITED ROAD SERVICE AREA

Shall the existence of the Rockhill Limited Road Service area be continued for an additional period of three (3) years after December 31, 1998 until December 31, 2001?

2 Section 2. That Section 27.20.320 of the Anchorage Municipal  
3 Code is hereby amended to read as follows:  
4

5 Pursuant to section 27.10.050, there is established a  
6 board of supervisors to administer the Rockhill Limited Road  
7 Service Area (RLRSA). The board shall consist of three  
8 members appointed by the mayor and confirmed by the Assembly  
9 to administer the service area until the regular election of  
10 October 1990, at which time the supervisors will be elected  
11 for staggered terms. Initial terms of supervisors elected at  
12 the regular election of October 1990 shall be elected by lot.  
13 [THE SERVICE AREA WILL EXPIRE ON DECEMBER 31, 1998, UNLESS IT  
14 IS EXTENDED BY VOTE IN THE AREA AFFECTED AT THE REGULAR  
15 ELECTION OF APRIL 1998.]  
16

17 Section 3. That Section 27.30.590 of the Anchorage Municipal  
18 Code is hereby amended to read as follows:  
19


20 There is established, pursuant to Section 9.01 of the  
21 Charter, a limited road service area within the municipality  
22 to be the Rockhill Limited Road Service Area of the  
23 municipality, as outlined on the map located in section  
24 27.30.700.  
25

26 The Rockhill Limited Road Service Area shall contribute  
27 funds expressly for the maintenance of roads commencing  
28 January 1, 1990, and shall end on December 31, [1998] 2001,  
29 unless the service area is extended by an affirmative vote of  
30 the service area [AFFECTED] at the regular election of April  
31 [1998] 2001. The mill rate shall not exceed 1.50 mills in any  
32 calendar year.  
33

34 Section 4. Except for Section 3, this ordinance shall become  
35 effective upon passage and approval. Section 3 and the  
36 proposition contained in Section 1 shall become effective upon  
37 certification of the regular election on the proposition  
38 called for by this ordinance, but only if that proposition is  
39 approved by a majority of the qualified voters voting on the  
40 proposition.
