## AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE EAGLE RIVER-CHUGIAK PARK AND RECREATIONAL SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 21, 1998, A BALLOT PROPOSITION APPROVING ADDITIONAL VOTER MANDATED SERVICES UP TO AN ADDITIONAL 0.25 MILLS. AND CAPITAL IMPROVEMENTS

WHEREAS the Eagle River-Chugiak Park and Recreational Service Area Board of Supervisors has recommended additional park and recreational services up to a cost of an additional 0.25 mills; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. A ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Eagle River-Chugiak Park and Recreational Service Area at the regular municipal election to be held on April 21, 1998:

## MANDATING ADDITIONAL SERVICES IN THE EAGLE RIVER-CHUGIAK PARKS AND RECREATION SERVICE AREA UP TO AN ADDITIONAL 0.25 MILLS

Shall increased park and trail maintenance services, increased recreational programming for service area youth and additional development of parks, trails, safe play areas and related facilities up to an additional 0.25 mills be mandated in the Eagle River Park and Recreational Service Area?

Approval of this proposition will increase the maximum mill rate 0.25 mills from the current 0.5 mills to 0.75 mills in the Eagle River-Chugiak Park and Recreational Service Area commencing January 1, 1999 and raise the tax increase limitation (tax cap) as provided in Charter §14.03(b)(2).

Section 2. Anchorage Municipal Code section 27.30.090 is hereby amended to read as follows:

27.30.090 Eagle River-Chugiak Parks and Recreation[AL] Service Area.

A. There is established, pursuant to section 9.01 of the Charter, a service area within the municipality to be the Eagle River-Chugiak Parks and Recreation[AL] Service Area

(ERCPRSA) [OF THE MUNICIPALITY], as outlined on the map located in section 27.30.700.

**B**. Parks and recreation[AL] services shall be provided in the Eagle River-Chugiak Parks and Recreation[AL] Service Area not exceeding a mill rate of 0.75 mills[. THE MILL RATE SHALL NOT EXCEED 0.50 MILL] in any calendar year.

Section 3. Sections 1. and 3. of this ordinance shall become effectively immediately upon passage and approval of this ordinance by the Assembly. The proposition contained in Section 1. and Section 2. of this ordinance shall become effective upon certification of the regular municipal election to be held April 21, 1998 if, but only if, the proposition contained in Section 1. is approved by a majority of the qualified voters voting on the question.
