AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE ZONING DISTRICT SUBSECTIONS 21.40.030 I. (R-1 AND R-1A SINGLE-FAMILY RESIDENTIAL), 21.40.040 I. (R-2A AND R-2D TWO-FAMILY RESIDENTIAL), 21.40.045 I. (R-2M MULTI-FAMILY RESIDENTIAL), 21.40.100 I. (R-8, RURAL RESIDENTIAL), 21.40.110 I. (R-9 RURAL RESIDENTIAL), 21.40.115 G. (R-10 RESIDENTIAL ALPINE), AND 21.40.120 I. (D-2 AND D-3 RESIDENTIAL) TO INCREASE THE MAXIMUM HEIGHT OF ACCESSORY BUILDINGS TO NOT GREATER THAN FIVE FEET (5') LESS THAN THE MAXIMUM PERMITTED HEIGHT FOR PRINCIPAL STRUCTURES.

### THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. Anchorage Municipal Code subsection 21.40.030 I. is hereby amended to read as follows:

## 21.40.030 R-1 and R-1A single-family residential districts.

 I. Maximum height of structures. Except as otherwise provided in this title, no portion of a principal structure shall exceed 25 feet in height. Accessory buildings shall not exceed 20 [12] feet in height.

Except as otherwise provided in this title, no portion of a principal structure shall exceed 25 feet in height, or 30 feet in height when 30 percent of the site is preserved as open space with ground cover in accordance with subsection M of this section. Accessory buildings shall not exceed a height of five feet less than the maximum height of the principal structure [12 FEET IN HEIGHT].

Accessory buildings shall not exceed a height of five feet less than the maximum height of the principal structure [12 FEET IN HEIGHT].
