AN ORDINANCE SETTING THE RATE OF TAX LEVY AND LEVYING TAXES FOR THE
MUNICIPALITY OF ANCHORAGE AREAWIDE GENERAL PURPOSES INCLUDING
MUNICIPAL SCHOOLS AND ALL SERVICE AREAS OF THE MUNICIPALITY FOR THE
MUNICIPAL TAX YEAR 1998

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. The Municipal Assembly hereby fixes the rate of tax levy for the Municipality
for the tax year 1998 for Areawide General Purposes, including Areawide Schools, and all
service areas of the Municipality. The Municipal Assembly levies this tax upon the full value of
all assessed taxable real and personal property, as follows.

Section 36. Anchorage Building Safety Service Area a tax of .01 mills.

Section 37. As in previous years, property taxes billed reflect prior year property taxes collected over the amount approved by the Assembly. For 1998 this amount is \$1,996,251 for 1996 tax collections. The property tax amount approved for 1998 (the "amount approved by the Assembly for the preceding year" to be used in the determination of the 1999 tax limitation), including real property, personal property, and municipal utilities services assessment (MUSA), as defined by Anchorage Municipal Charter section 14.03(a) is as follows:

Anchorage School District	<u>110,846,717 *</u>

The 1998 calendar year tax billings for ASD is \$105,887,055. *

* The Anchorage School District amounts will need to be reduced if all three education bond propositions are not approved by the voters at the April 21, 1998 election.

Section 38. The tax billings for 1998 will be reduced by the amount of 1996 property taxes levied over the Assembly approved levy. The mill rates in sections 3 - 36 reflect such adjustments.

Section 39. This ordinance shall become effective upon passage and approval by the Anchorage Municipal Assembly.
