AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AUTHORIZING LONG TERM LEASES BETWEEN THE MUNICIPALITY OF ANCHORAGE AS LESSOR AND THE T-HANGAR OWNERS AS LESSEES OF LOT 1C, BLOCK 5, MERRILL FIELD REPLAT ADDITION NO. 5, LOCATED SOUTH OF RUNWAY 6-24 AND EAST OF RUNWAY 15-33.

WHEREAS, the Assembly, under AO 95-143, provided guidance to the Administration and the T-Hangar Owners to work together to provide an alternate site for the T-Hangars on Merrill Field, develop a new section of the building code addressing the uniqueness of the T-Hangars and provide for a long term lease agreement; and

WHEREAS, the Assembly approved AO 96-148 which amended the Anchorage Municipal Code allowing the relocation of the existing T-Hangars to an alternate site on Merrill Field; and

WHEREAS, Merrill Field Replat Addition No. 5 was recorded on January 23, 1998 which created Lot 1C, the new site for the T-Hangars; and

WHEREAS, disposal by lease of the real property herein described includes the provisions necessary for the relocation of the T-Hangars to the new site on Merrill Field; and

WHEREAS, the Municipality, as a sponsor of Federal grant agreements for airport development, assumes certain obligations which require it to maintain and operate its airport facilities safely and efficiently and in accordance with these obligations, airport property shall be restricted to aeronautical uses unless a determination is made by the Federal Aviation Administration that it is in surplus of that need. These grant obligations have a considerable impact on property values at Merrill Field Airport; and

WHEREAS, the current Merrill Field lease rate is consistent for all Merrill Field Airport land leases and considered to be the market rate for airport properties that are restricted to aeronautical uses. Current Merrill Field lease rates are considerably higher than other non-municipal owned airports within the local area; and

WHEREAS, AMC Chapter 25.30.020 states that disposal of Municipal land shall be by ordinance only; now, therefore

THE ANCHORAGE MUNICIPAL ASSEMBLY ORDAINS:

Section 1. The Municipality of Anchorage is authorized to lease Lot 1C, Block 5, Merrill Field Replat Addition No. 5, located within the Anchorage Recording District of the Third Judicial District, composed of approximately 75,396 square feet, to the T-Hangar Owners upon the terms and conditions summarized in Assembly Memorandum No. 482-98 submitted to the Assembly in conjunction with this ordinance and attached hereto.

Section 2. This ordinance shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.
