OF ANCHORAGE CREATING MUNICIPALITY THE AN ORDINANCE OF NATURAL GAS LINE SPECIAL ASSESSMENT DISTRICT NO. 1G98 - NATURAL **DETERMINING TO** GAS LINE IN THE EAST EAGLE RIVER VALLEY AREA AND PROCEED WITH PROPOSED IMPROVEMENTS THEREIN.

THE ANCHORAGE ASSEMBLY FINDS:

Section 1. A petition for creation of a Special Assessment District to provide public improvements has been received by the Municipality and has been signed by sufficient and proper petitioners. The petition is for the purpose of re-enforcing the existing gas line in Eagle River Valley by crossing Eagle River, extending the existing gas line with additional gas main (refer to Map 1), and providing service lines to the east end of the Eagle River Valley (refer to Map 2).

Section 2. The aforementioned public improvements are necessary and of benefit to the following described property:

Special Assessment District 1G98

Section 3. The improvements described in Section 1 are estimated to cost \$937,000.

NOW THEREFORE, THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. There is established Natural Gas Line Special Assessment District No. 1G98, comprised of the property previously herein described.

Section 2 The Municipality shall proceed with the aforementioned public improvement.

Section 3. One hundred percent (100%) of the costs of the improvement as defined in Anchorage Municipal Code Section 19.30.030 shall be financed with special assessment bonds, and assessed to the parcels in the district under Anchorage Municipal Code section 19.30.040b.

Section 4. Special assessments may be paid in installments as provided in the resolution levying assessments. Such installments may include a service charge for collections established in accordance with Municipal Policies and Procedures.

Section 5. Assessments levied pursuant to this Ordinance shall be calculated on an equal basis by dividing the total cost of the project by the number of benefited lots in the district. The Assembly finds that assessments calculated on this basis are proportionate to the benefit received from and the burden imposed upon the improvement.

Section 6. An account shall be kept of all costs of the improvement. The Mayor forthwith shall cause this Ordinance to be recorded in the office of the Anchorage District Recorder, and prepare the assessment roll.
