AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTIONS 9.04.010, 9.32.070  
AND 9.30.030 TO PROHIBIT VEHICLES OTHER THAN MUNICIPAL BUSES FROM  
STANDING, STOPPING OR PARKING IN A MUNICIPAL TRANSIT BUS STOP ZONE.

THE ANCHORAGE ASSEMBLY ORDAINS

Section 1. Anchorage Municipal Code Section 9.04.010 is hereby amended by adding new  
definitions to read as follows:

Bus, Municipal Transit means any vehicle used to transport passengers for hire by the  
municipality's mass transit system.

Support Vehicle, Municipal Transit means any vehicle used to provide  
maintenance, administrative or other direct support to the delivery of Municipal  
transportation services.

Section 2. Anchorage Municipal Code Section 9.30.070 is hereby amended to read as follows:

9.32.070 Use of bus and taxicab stands by other vehicles.

[EXCEPT WHILE TEMPORARILY STOPPED FOR THE PURPOSE OF AND WHILE  
ACTUALLY ENGAGED IN LOADING OR UNLOADING PASSENGERS AT A TIME  
WHEN SUCH STOPPING DOES NOT INTERFERE WITH A BUS OR TAXICAB  
WAITING TO ENTER OR ABOUT TO ENTER A BUS STOP ZONE OR A TAXICAB  
STAND ZONE, RESPECTIVELY, N]

A. No person may

1.[A.] Stop, stand or park a vehicle other than a Municipal Transit bus or a  
Municipal Transit support vehicle in a Municipal Transit bus stop zone  
which has been officially designated by appropriate signs; or

2. [B] Stop, stand or park a vehicle other than a taxicab in a taxicab stand zone which has been officially designated by appropriate signs.

(CAC 9.32.070; AO No. 78-72; AO No. 87-142)

**Section 3.** Anchorage Municipal Code subsection 9.30.030 A.10. is hereby amended to read as follows:

**9.30.30** **Stopping, standing or parking prohibited in specified places.**

Except when necessary to avoid conflict with other traffic, or in compliance with law or the direction of a police officer or official traffic control device, no person may:

A. Stop, stand or park a vehicle

\*\*\*  
10 At any place immediately adjacent to a red painted curb except Municipal Transit buses and Municipal Transit support vehicles at designed Municipal Transit bus stops.  
\*\*\*

*(The remainder of this section is not affected by this ordinance and is therefore not set out.)*

**Section 4.** This ordinance shall become effective immediately upon its passage and approval by the Assembly.
