A petition for creation of a Special Assessment District to 12 construct a public alley has been received by the Municipality and has been signed 13 by sufficient and proper petitioners. The petition is for the purpose of constructing 14 the 'H' Street / 'I' Street Alley from West Fifteenth Avenue to West Sixteenth Avenue 15 with asphalt paving as shown on the attached map. 16 17 18 Section 2. The aforementioned public improvement is necessary and of 19 benefit to the following described property: 20 21 Special Assessment District No. 1P98 22 All the property in BLOCKS 42A & 42D, 23 of the Welsch's Subdivision (of the 24 25 South Addition) 26 27 Section 3. The improvements described in Section 1 have an estimated 28 assessable cost of \$46,000. 29 30 31 Section 4. The improvements described in Section 1 have not been 32 included in an approved capital improvement budget/program nor has funding been 33 identified for the construction of the project. 34 35 NOW THEREFORE, THE ANCHORAGE ASSEMBLY ORDAINS: 36 37 38 There is established Alley Reconstruction Special Assessment Section 1. 39 District No. 1P98 comprised of the property previously herein described. 40 41 Section 2. The Municipality shall proceed with the aforementioned public 42 improvement. 43 44 45 The Municipality shall include this project in the capital Section 3 46 improvement budget/program and shall pursue the necessary funding. 47 48 49 50 51 52 AM 1144-98

Section 4. Costs assessed to benefited parcels shall include, if applicable, costs for sewer and water connections, and project costs that are the lesser amount of: (1)construction contract costs plus twenty percent (20%) for non-contract costs, plus actual acquisition costs; or (2)the last approved estimate plus ten percent (10%). Any improvements that are reconstructed, such as alley entrances and sidewalks, shall be assessed in accord with Policy and Procedure 46-2, in which the assessable cost is ten percent (10%) of the total project cost for the reconstructed improvements.

Section 5. Assessments levied pursuant to this Ordinance shall be calculated based upon the zone, weighted area method of assessment within the first 90 (ft) of each lot. The Assembly finds that assessments calculated on this basis are proportionate to the benefit received from and the burden imposed upon the improvement.

The Mayor shall cause proper account of all costs to be kept of Section 6. the public improvement and, after completion of the improvement, shall have an Assessment roll prepared and presented to the Assembly for the purpose of the assessing the cost of the improvement to the benefited properties.


The Mayor forthwith shall cause this Ordinance to be recorded Section 7. in the office of the Anchorage District Recorder.
