A RESOLUTION AUTHORIZING AMENDMENT TO THE 1997 ACTION PLAN INCLUDING ALLOCATION OF \$1,163,005 IN REPROGRAMMED CDBG FUNDS AND PROGRAM INCOME, \$1,201,233 IN 1997 CDBG FUNDS, AND COMMITTING \$2,100,651 IN FUTURE CDBG ENTITLEMENTS FOR THIRTEEN (13) CAPITAL PROJECTS.

WHEREAS, the Housing and Community Development Consolidated Plan approved by the Assembly includes a citizen participation plan that outlines the procedures required for making amendments to the 1997 Action Plan; and

WHEREAS, in conjunction with the development of the Municipality of Anchorage Consolidated Plan (1995-2000) and 1997 Action Plan, a Request for Proposal (RFP) was published and an interdepartmental solicitation was offered, both of which furnished citizens with information governing the amount of CDBG funds available for proposed community development activities benefiting low to moderate income persons and the range of activities that may be undertaken; and

WHEREAS, the Housing & Neighborhood Development Commission appointed an evaluation committee to review the proposed projects responsive to the RFP and the interdepartmental solicitation and make funding recommendations; and

WHEREAS, committee's funding recommendations were presented to the Housing and Neighborhood development commission in December, published in the Anchorage Daily News, and the public was invited to comment on the recommendations during a thirty day period and a public hearing; and

WHEREAS, the Housing & Neighborhood Development Commission passed a resolution recommending Assembly approval of the proposed projects on January 21, 1998; and

WHEREAS, to assure timely expenditure of program funds, and in accordance with applicable rules and regulations, a proposal to defer funding of two previously funded CDBG capital projects until receipt of 1998 entitlement funds, and cancel two other stalled projects, as outlined in the attached AM, was published for public comment in the Anchorage Daily News; and

WHEREAS, the necessary steps to make a formal amendment to the Consolidated Plan and Action Plan have been duly taken;

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That amendments to the 1997 Action Plan of the Housing and Community Development Consolidated Plan outlined in AM-~~78-98~~ incorporated herein by reference, are hereby endorsed;

1 Section 2. That \$1,201,233 in 1997 Community Development Block Grant funds, \$1,163,005 in
2 program income and reprogrammed funds and \$2,100,651 in future CDBG entitlements are
3 hereby allocated to the thirteen (13) projects listed on Attachment B, incorporated herein by
4 reference; and

6 Section 3. This resolution shall become effective immediately upon passage and approval by
7 the Anchorage Assembly.
