A RESOLUTION REVISING THE APPROVED 1998 GENERAL GOVERNMENT CAPITAL  
IMPROVEMENT BUDGET (CIB) AND THE 1998-2003 GENERAL GOVERNMENT CAPITAL  
IMPROVEMENT PROGRAM (CIP)

WHEREAS, the Assembly approved the 1998 General Government Capital  
Improvement Budget/Program (CIB/CIP) for the Municipality of Anchorage on November 4, 1997, per  
AO 97-122(S) as amended and AR 97-224(S) as amended; and

WHEREAS, the Administration expects to introduce the April 1998 Bond Propositions  
to the Assembly February 3, 1998 in a total amount different than that shown in the Approved 1998-  
2003 General Government CIB/CIP.
