A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING WHEN TENDERED THREE HUNDRED THOUSAND DOLLARS (\$300,000) FROM THE FEDERAL AVIATION ADMINISTRATION AIRPORT IMPROVEMENT PROGRAM GRANT, AND TEN THOUSAND DOLLARS (\$10,000) FROM THE ALASKA STATE DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES GRANT; AND APPROPRIATING SAID GRANTS AND TEN THOUSAND DOLLARS (\$10,000) FROM AIRPORT RETAINED EARNINGS TO MERRILL FIELD'S CAPITAL IMPROVEMENT FUND FOR CONSTRUCTING RIAT SECURITY FENCING.

NOW, THEREFORE, BE IT RESOLVED, by the Assembly of the Municipality of Anchorage

Section 1. That the Municipality of Anchorage hereby accepts, when tendered, the Federal Aviation Administration (FAA) Grant offer of Three Hundred Thousand Dollars (\$300,000) and hereby undertakes and agrees to use those funds for the construction of RIAT Security Fencing.

Section 2. That the Municipality of Anchorage hereby accepts, when tendered, the State of Alaska Department of Transportation and Public Facilities (SOA DOT&PF) grant for Ten Thousand Dollars (\$10,000), and appropriates both grants and \$10,000 from airport retained earnings to Merrill Field's Capital Improvement Fund.
