A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE DELETING, ACCEPTING, AND  
APPROPRIATING STATE OF ALASKA LEGISLATIVE GRANTS TO THE MUNICIPALITY OF  
ANCHORAGE FOR THE ANCHORAGE SCHOOL DISTRICT PER SENATE BILL 107

WHEREAS, on August 19, 1997, the Anchorage Assembly accepted and  
appropriated Four Hundred Seventy Six Thousand Six Hundred Seventy Seven Dollars  
(\$476,677) of State of Alaska grants to the Anchorage School District; and

WHEREAS, Four Hundred One Thousand Six Hundred Sixty Seven Dollars  
(\$401,677) of the grants appropriated August 19, 1997 were the result of reprogramming grants  
previously issued to the Municipality for Anchorage School District capital improvements; and

WHEREAS, following their 1997 annual fiscal audit, it was determined that an  
additional Ten Thousand Eight Hundred Sixty Five Dollars (\$10,865) was available from the  
unexpended balances of grants reappropriated to the Municipality for Anchorage School District  
capital improvements and should be included in the amount reprogrammed by the State; and

WHEREAS, the Administration and the Assembly have reviewed the grants  
offered by the State of Alaska; and

~~WHEREAS, on \_\_\_\_\_, 1998 a duly advertised public hearing was held in  
accordance with Section 6.10.085 of the Municipal Code; and~~

WHEREAS, the State of Alaska grants are available for repeal and  
reappropriation.

NOW, THEREFORE, the Anchorage Assembly hereby resolves:

Section 1. That prior Anchorage School District appropriations in the amount of  
Ten Thousand Eight Hundred Sixty Five Dollars (\$10,865) are hereby deleted.

Section 2. That State grants in the amount Ten Thousand Eight Hundred Sixty  
Five Dollars (\$10,865) are hereby accepted and appropriated to the Municipality for the  
Anchorage School District.

Section 3. That the amount set forth in Section 4 shall be and hereby is a  
supplemental appropriation to the Anchorage School District for the Municipality's 1998 fiscal  
year.

Section 4. That the net appropriation by fund is as follows:
