- * Section 1. AS 29.45.050 is amended by adding a new subsection to read:
 - (o) A municipality may by ordinance partially or totally exempt all or some types of deteriorated property from taxation for up to five years. The municipality may provide for renewal of the exemption under conditions established in the ordinance. A municipality may by ordinance permit deferral of payment of taxes on all or some types of deteriorated property for up to five years. The municipality may provide for renewal of the deferral under conditions established in the ordinance. In this subsection, "deteriorated property" means real property
- 13 (1) that has been the subject of an order by a government agency 14 requiring the property to be vacated, condemned, or demolished by reason of

2	(2) on which a structure or other improvement not less than 15 years
