WHEREAS, Kenneth Lane was hired by the Municipality of Anchorage on December 12, 1974 as a Generation Plant Operator for Municipal Light & Power; and

WHEREAS, during his tenure. Ken held a variety of positions such as Generation Operator Mechanic, Generation Electrical Leadman, Generation Electrical Foreman, SCADA (System Control and Data Acquisition) Specialist, and Power Dispatcher; and

WHEREAS, during his tenure as Generation Electrical Foreman:

Ken served as ML&P project leader and rep to General Electric contractor for the initial installation of Generating Unit 7: he was innovative in increasing the reliability of Generating Unit 7: and he promoted the startup and operation of the combined cycle plant for ML&P Units 5, 6, & 7 (these generating units are still standing and operating as our main source of power production to this date);

Ken set up and implemented Generation Electrical Crew training on relay settings and testing, starting out as a one-man electrical crew and leaving five competently trained electrical crewmen;

Ken spent many late nights working on the former P-50 Westinghouse Computer Control System for Turbines, designing specialized software and tools to speed up programming;

Ken served as ML&P's SCADA Specialist from 1986 to 1989, and was instrumental in design, development, and installation of the SCADA & System Control System and the Automatic Generation Control (AGC) referred to as "Dunstan," which brought ML&P from manual control of the electric supply system to the cutting edge with latest computerized SCADA technology; and

WHEREAS, on October 8, 1989, Ken was promoted to Power Dispatcher and was instrumental in ensuring the most economic sales and dispatching of power to other utilities; he developed ML&P's computerized Energy Accounting Data Base and Spreadsheets; and for nearly 10 years he has been responsible for restoring power to affected areas throughout the Municipality quickly and safely; and

WHEREAS, his dedication, loyalty, and commitment to providing Municipal Light & Power customers the best service possible has been his number one priority for nearly 24 years.
