A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TEN THOUSAND FIVE HUNDRED DOLLARS (\$10,500) FROM THE FIRE SERVICE AREA (0131) FUND BALANCE TO THE ANCHORAGE FIRE DEPARTMENT; EIGHTEEN THOUSAND NINE HUNDRED DOLLARS (\$18,900) FROM THE ANCHORAGE METROPOLITAN POLICE SERVICE AREA (0151) FUND BALANCE TO THE ANCHORAGE POLICE DEPARTMENT; AND SIX HUNDRED DOLLARS (\$600) FROM THE AREAWIDE GENERAL (0101) FUND BALANCE TO THE ANCHORAGE FIRE DEPARTMENT TO OBTAIN OUTSIDE CONTRACT LEGAL SERVICES TO ASSIST IN THE LITIGATION OF *GALLION, JACK, et al V. AP&FRS*, CASE NO. 3AN-98-4563.

THE ANCHORAGE ASSEMBLY RESOLVES


Section 1: That the sum of Ten Thousand Five Hundred Dollars (\$10,500) is hereby appropriated from the Fire Service Area (0131) Fund Balance to the Anchorage Fire Department to obtain outside legal services to assist in the litigation of *Gallion, Jack, et al v. AP&FRS*, Case No. 3AN-98-4563.

Section 2: That the sum of Eighteen Thousand Nine Hundred Dollars (\$18,900) is hereby appropriated from the Anchorage Metropolitan Police Service Area (0151) Fund Balance to the Anchorage Police Department to obtain outside legal services to assist in the litigation of *Gallion, Jack, et al v. AP&FRS*, Case No. 3AN-98-4563.


Section 3: That the sum of Six Dollars (\$600) is hereby appropriated from the Areawide General (0101) Fund Balance to the Anchorage Fire Department to obtain outside legal services to assist in the litigation of *Gallion, Jack, et al v. AP&FRS*, Case No. 3AN-98-4563.

Section 4: That this Resolution shall become effective immediately upon passage and approval by the Anchorage Municipal Assembly.
