A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE HUNDRED THOUSAND DOLLARS (\$100,000) FROM THE AREAWIDE GENERAL (0101) FUND BALANCE TO THE OFFICE OF THE MUNICIPAL ATTORNEY TO SECURE ADDITIONAL CONTRACT LEGAL SERVICES FOR THE SALE OF THE ANCHORAGE TELEPHONE UTILITY.

THE ANCHORAGE ASSEMBLY RESOLVES:
