## ANCHORAGE, ALASKA AR No. 98- 332

A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE, ALASKA, ACCEPTING A U.S. DEPARTMENT OF THE INTERIOR, U.S. GEOLOGICAL SURVEY GRANT IN THE AMOUNT OF FORTY THOUSAND DOLLARS (\$40,000) AND APPROPRIATING SAID GRANT TO THE ANCHORAGE WATER & WASTEWATER UTILITY'S CAPITAL IMPROVEMENT BUDGET FOR THE "IMPLEMENTATION STRATEGY AND ACTION PLAN FOR THE MIGRATION TO FGDC-ENDORSED NATIONAL STANDARDS FOR GEOSPATIAL DATA" PROJECT.

WHEREAS, the U.S. Department of the Interior, U.S. Geological Survey (the "USGS") has offered the Municipality of Anchorage (the "Municipality") a grant of funds not to exceed \$40,000 to be applied toward the cost of the Anchorage Water & Wastewater Utility's (AWWU) "Implementation Strategy and Action Plan for the Migration to FGDC-Endorsed National Standards for Geospatial Data" project; and

WHEREAS, there is a need for said project; and

WHEREAS, the Municipality agrees to accept the recommendations of said project; and

WHEREAS, the Municipality agrees to accept the terms and conditions of the grant offer.

NOW THEREFORE, the Assembly of Anchorage resolves:

Section 1. That the subject federal funds granted to the Municipality are accepted

Section 2. That the Mayor of Anchorage acknowledge the grant offer and that he transmit to the USGS an executed copy of this resolution accepting said grant.

Section 3. That the sum of *Forty Thousand Dollars* (\$40,000) be appropriated from the USGS grant funds to AWWU's Capital Improvement Budget for the purpose of financing the "Implementation Strategy and Action Plan for the Migration to FGDC-Endorsed National Standards for Geospatial Data" project.
