A RESOLUTION AUTHORIZING THE MUNICIPALITY TO GRANT OUTDOOR PUBLIC DISPLAY SITE, PRIVATE SANITARY SEWER MAINTENANCE, ACCESS, AND EARTHERN SCREENING BERM EASEMENTS ACROSS PORTIONS OF TRACTS A AND B, BARTLETT HIGH SCHOOL, AND LOTS 1 AND 3, SECTION 12, T13N, R3W, SEWARD MERIDIAN, CENTENNIAL PARK SITES.

WHEREAS, easements across Bartlett High School and Centennial Park Sites are required to facilitate construction of Alaska Native Heritage Center improvements, and

WHEREAS, the subject easements are found to be of no substantial value to the Municipality.

NOW, THEREFORE, the Anchorage Assembly Resolves:

SECTION 1. The Administration is authorized to grant the requested easements to Alaska Native Heritage Center, Inc., an Alaska non-profit corporation in the following locations:

OUTDOOR DISPLAY SITE LOCATION: A portion of Tract "A", E.L. Bob Bartlett School Site according to the official plat thereof filed as Plat No. 73-25 in the Anchorage Recording District, Third Judicial District, State of Alaska, and located within the Northeast 1/4 of Section 12, Township 13 North, Range 3 West, Seward Meridian, Alaska, described by metes and bounds as: Commencing at the southeast corner of said Northeast 1/4 of Section 12; thence on the east line thereof N00°04'40"W 689.60 feet to the True Point of Beginning of this description; thence N00°04'40"W 460.24 feet on the east boundary of Tract "A" to the northeast corner of said Tract "A"; thence on the north boundary of Tract "A" S89°54'40"W 874.42 feet; thence departing said north line of Tract "A" S40°11'56"W 264.21 feet; thence S27°24'53"E 875.24 feet; thence N09°27'57"E 36.75 feet to the point of curvature of a curve concave to the southeast having a radius of 310.00 feet; thence northeasterly on said curve through a central angle of 27°49'06" 150.51 feet; thence N37°17'03"E 90.41 feet to the point of curvature of a curve concave to the northwest having a radius of 190.00 feet; thence northeasterly on said curve through a central angle of 21°11'58" 70.30 feet; thence N16°05'05"E 20.95 feet to the point of curvature of a curve concave to the southeast having a radius of 310.00 feet; thence northeasterly on said curve through a central angle of 26°44'24" 144.68 feet; thence N42°49'29"E 22.72 feet to the point of curvature of a curve concave to the south having a radius of 260.00 feet; thence easterly on said curve through a central angle of 76°10'11" 345.65 feet to the True Point of Beginning, embracing an area of 535,792 square feet, being 12.300 acres, more or less.

Bob Bartlett School Site according to the official plat thereof filed as Plat No. 73-25 in the Anchorage Recording District, Third Judicial District, State of Alaska, and located within the Northeast 1/4 of Section 12, Township 13 North, Range 3 West, Seward Meridian, Alaska, described by metes and bounds as: Commencing at the southeast corner of said Northeast 1/4 of Section 12; thence on the east line thereof N00°04'40"W 246.24 feet to the True Point of Beginning of this description; thence along the east boundary of Tract "A" N00°04'40"W 180.00 feet; thence N18°29'29"W 162.17 feet to the beginning of a nontangent curve concave to the south, having a radius point bearing S32°33'51"W 140.00 feet; thence westerly on said curve through a central angle of 25°35'09" 62.52 feet; thence departing said curve S07°46'04"E 277.55 feet; thence S42°03'54"E 107.63 feet to the True Point of Beginning, embracing an area of 22,538 square feet, being 0.517 acres, more or less.

SECTION 2. This resolution shall take effect immediately upon passage and approval.
