A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING EIGHTEEN THOUSAND, FOUR HUNDRED, NINETY-EIGHT DOLLARS ( $\$ 18,498$ ) FROM THE ALASKA STATE COUNCIL ON THE ARTS, THIRTY-SEVEN THOUSAND DOLLARS ( $\$ 37,000$ ) FROM THE ANCHORAGE MUSEUM ASSOCIATION, THIRTEEN THOUSAND, TWO DOLLLARS ( $\$ 13,002$ ) FROM THE ANCHORAGE MUSEUM FOUNDATION, EIGHT THOUSAND DOLLARS $(\$ 8,000)$ FROM ANTICIPATED MISCELLANEOUS REVENUES AND EIGHTEEN THOUSAND, NINE HUNDRED FIFTY DOLLARS $(\$ 18,950)$ AS A CONTRIBUTION FROM THE CY98 MUSEUM OPERATING BUDGET TO THE STATE CATEGORICAL GRANTS FUND (0231) FOR SEASON SUPPORT AT THE ANCHORAGE MUSEUM OF HISTORY AND ART.

THE ANCHORAGE ASSEMBLY RESOLVES:
Section 1. That a sum not to exceed EIGHTEEN THOUSAND, FOUR HUNDRED, NINETY-EIGHT DOLLARS $(\$ 18,498)$ is hereby appropriated from a grant awarded by the Alaska State Council on the Arts, THIRTY-SEVEN THOUSAND DOLLARS ( $\$ 37,000$ from the Anchorage Museum Association, THIRTEEN THOUSAND, TWO DOLLARS (\$13,002 from the Anchorage Museum Foundation, EIGHT THOUSAND DOLLARS $(\$ 8,000)$ in anticipated miscellaneous revenues and EIGHTEEN THOUSAND, NINE HUNDRED FIFTY DOLIARS $(\$ 18,950)$ as a contribution from appropriated funds for Museum season support.
