4 DOLLARS (\$37,000) FROM THE ANCHORAGE MUSEUM ASSOCIATION, THIRTEEN
5 THOUSAND, TWO DOLLARS (\$13,002) FROM THE ANCHORAGE MUSEUM
6 FOUNDATION, EIGHT THOUSAND DOLLARS (\$8,000) FROM ANTICIPATED
7 MISCELLANEOUS REVENUES AND EIGHTEEN THOUSAND, NINE HUNDRED FIFTY
8 DOLLARS (\$18,950) AS A CONTRIBUTION FROM THE CY98 MUSEUM
9 OPERATING BUDGET TO THE STATE CATEGORICAL GRANTS FUND (0231) FOR
10 SEASON SUPPORT AT THE ANCHORAGE MUSEUM OF HISTORY AND ART.

12 THE ANCHORAGE ASSEMBLY RESOLVES:

14 Section 1. That a sum not to exceed EIGHTEEN THOUSAND,

16 FOUR HUNDRED, NINETY-EIGHT DOLLARS (\$18,498) is hereby

18 appropriated from a grant awarded by the Alaska State Council on

20 the Arts, THIRTY-SEVEN THOUSAND DOLLARS (\$37,000 from the

22 Anchorage Museum Association, THIRTEEN THOUSAND, TWO DOLLARS

24 (\$13,002 from the Anchorage Museum Foundation, EIGHT THOUSAND

26 DOLLARS (\$8,000) in anticipated miscellaneous revenues and

28 EIGHTEEN THOUSAND, NINE HUNDRED FIFTY DOLLARS (\$18,950) as a

30 contribution from appropriated funds for Museum season support.


