2 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE, ALASKA, ACCEPTING A  
3 STATE OF ALASKA, DEPARTMENT OF ENVIRONMENTAL CONSERVATION GRANT IN  
4 THE AMOUNT OF THIRTY SEVEN THOUSAND, SIX HUNDRED FORTY THREE  
5 DOLLARS (\$37,643) AND APPROPRIATING SAID GRANT TO THE ANCHORAGE  
6 WASTEWATER UTILITY'S CAPITAL IMPROVEMENT FUND FOR THE 5<sup>TH</sup> AND EAGLE  
7 SEWER UPGRADE PROJECT.

10 WHEREAS, the State of Alaska Department of Environmental Conservation (the  
11 "State") has offered the Municipality of Anchorage (the "Municipality") a grant of funds not to  
12 exceed \$37,643 to be applied toward the cost of the Anchorage Water & Wastewater Utility's  
13 (AWWU) 5<sup>TH</sup> AND EAGLE SEWER UPGRADE project ; and

15 WHEREAS, there is a need for said project; and  
16

17 WHEREAS, the Municipality agrees to maintain said project; and  
18

19 WHEREAS, the Municipality agrees to accept the terms and conditions of the grant  
20 offer.

22 NOW THEREFORE, the Assembly of Anchorage resolves:  
23

24 Section 1. That the subject State funds granted to the Municipality are accepted.  
25

26 Section 2. That the Mayor of Anchorage acknowledge the grant offer and that he  
27 transmit to the State an executed copy of this resolution accepting said grant.  
28

29 Section 3. That the sum OF THIRTY SEVEN THOUSAND, SIX HUNDRED FORTY  
30 THREE DOLLARS (\$37,643) be appropriated from the State matching grant funds to the  
31 Anchorage Wastewater Utility's Capital Improvement Fund for the purpose of financing the  
32 5<sup>TH</sup> AND EAGLE SEWER UPGRADE project.
