AO NO. 98-131(S)

AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE TITLES 10 AND 14 BY ENACTING A NEW CHAPTER 10.65, BUSINESS LICENSES AND REGULATIONS, TO REQUIRE ALL THOSE HOLDING A BUSINESS LICENSE ENDORSEMENT TO SELL TOBACCO OR ANY PRODUCT CONTAINING TOBACCO TO DISPLAY A WARNING SIGN STATING THAT THE SALE OF TOBACCO TO PERSONS UNDER AGE 19 IS ILLEGAL, AND PROVIDING FOR FINES FOR NON-COMPLIANCE.

THE ANCHORAGE ASSEMBLY ORDAINS:

**Section 1:** That Anchorage Municipal Code 10 is hereby amended by enacting a new chapter 10.65, Warning Signs Against Sales to Tobacco to Minors, to read as follows:

**Chapter 10.65**

**WARNING SIGNS AGAINST SALES OF TOBACCO TO MINORS**

**10.65.010      Definitions**

A. "Person" includes and individual, firm, partnership, joint adventure, association, corporation, estate trust, business trust, receiver, or any group or combination acting as unit

**10.65.020      Warning signs required**

A person who holds a license endorsement issued under Alaska Statute 43.70.075 shall post on the licensed premises a warning sign as required by Alaska Statute 43.70.075 (f). ~~[described in this section. A warning sign required by this section must be at least 6 inches by 18 inches and must read in lettering at least 1.25 inches high: "The sale of tobacco products to persons under age 19 is illegal." A person holding an endorsement issued under Alaska Statute 43.70.075 shall display the sign in a manner conspicuous to a person purchasing or consuming tobacco products on the licensed premises.]~~

**Section 2:** That Anchorage Municipal Code Section 14.60.030 is amended to read as follows:

**14.60.030      Fine Schedule**
