ANCHORAGE, ALASKA AO NO. 99-63

AN ORDINANCE SETTING THE RATE OF TAX LEVY AND LEVYING TAXES FOR THE MUNICIPALITY OF ANCHORAGE AREAWIDE GENERAL PURPOSES INCLUDING MUNICIPAL SCHOOLS AND ALL SERVICE AREAS OF THE MUNICIPALITY FOR THE MUNICIPAL TAX YEAR 1999

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. The Municipal Assembly hereby fixes the rate of tax levy for the Municipality for the tax year 1999 for Areawide General Purposes, including Areawide Schools, and all service areas of the Municipality. The Municipal Assembly levies this tax upon the full value of all assessed taxable real and personal property, as follows.

Section 35. Eagle River-Chugiak Parks & Rec Service Area a tax of <u>0.53</u> mills.

Section 36. Anchorage Building Safety Service Area a tax of <u>0.01</u> mills.

Section 37. As in previous years, property taxes billed reflect prior year property taxes billed over the amount approved by the Assembly. For 1999 this amount is \$726,848 for 1997 tax collections. The property tax amount approved for 1999 (the "amount approved by the Assembly for the preceding year" to be used in the determination of the 2000 tax limitation), including real property, personal property, and municipal utilities services assessment (MUSA), as defined by Anchorage Municipal Charter section 14.03(a) is as follows:

General Government \$141,407,870* Anchorage School District <u>117,633,373</u>** \$259,041,243

The 1999 calendar year tax billings for ASD is \$112,983,347**

*The General Government amount will need to be decreased if two limited road service area mill levy increases are not approved at the April 20, 1999 Municipal election.

**The Anchorage School District amounts will need to be decreased if the education related bond proposition at the April 20, 1999 Municipal election is not approved.

Section 38. The tax billings for 1999 will be reduced by the amount of 1997 property taxes billed over the Assembly approved levy. The mill rates in sections 3 - 36 reflect such adjustments.

<u>Section 39</u>. This ordinance shall become effective upon passage and approval by the Anchorage Municipal Assembly.
