3 AN ORDINANCE ADOPTING THE 2000 GENERAL GOVERNMENT CAPITAL IMPROVEMENT 4 BUDGET AND APPROPRIATING SIX HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED 5 SEVENTY THREE DOLLARS (\$681,973) FROM THE STATE CATEGORICAL GRANT FUND (231); 6 THREE HUNDRED NINETY FIVE THOUSAND DOLLARS (\$395,000) TO THE ANCHORAGE 7 METROPOLITAN POLICE SERVICE AREA CAPITAL IMPROVEMENT PROGRAM FUND (451) FOR 8 THE PURCHASE AND EQUIPPING OF POLICE VEHICLES; AND TWO HUNDRED EIGHTY SIX 9 THOUSAND NINE HUNDRED SEVENTY THREE DOLLARS (\$286,973) TO THE ANCHORAGE 10 FIRE SERVICE AREA CAPITAL IMPROVEMENT PROGRAM FUND (431) FOR COMMUNICATION, 11 TECHNOLOGY, OR OTHER CAPITAL IMPROVEMENTS 12

WHEREAS, the Mayor has presented the Mayor's 2000 General Government 14 Capital Improvement Budget (CIB) for the Municipality of Anchorage to the Assembly in 15 accordance with Article XIII. Section 13.03 of the Municipal Charter; and 16 17

WHEREAS, on October 19, 1999 and October 26, 1999, duly advertised public hearings were held in accordance with Article XIII, Section 13.04 of the Municipal Charter.

NOW, THEREFORE, the Assembly hereby ordains:

1. That the Mayor's 2000 General Government Capital Improvement Budget is hereby approved for the Municipality of Anchorage, subject to receipt and appropriation of the necessary funds.

5. That the sum of Two Hundred Eighty Six Thousand Nine Hundred Seventy
Three Dollars (\$286,973) is hereby appropriated from the State Categorical Grant Fund (231)
to the Anchorage Fire Service Area Capital Improvement Program Fund (431) for
communication, technology or other capital improvement projects.
