AN ORDINANCE ADOPTING THE 2000 GENERAL GOVERNMENT CAPITAL IMPROVEMENT BUDGET AND APPROPRIATING SIX HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED SEVENTY THREE DOLLARS (\$681,973) FROM THE STATE CATEGORICAL GRANT FUND (231); THREE HUNDRED NINETY FIVE THOUSAND DOLLARS (\$395,000) TO THE ANCHORAGE METROPOLITAN POLICE SERVICE AREA CAPITAL IMPROVEMENT PROGRAM FUND (451) FOR THE PURCHASE AND EQUIPPING OF POLICE VEHICLES; AND TWO HUNDRED EIGHTY SIX THOUSAND NINE HUNDRED SEVENTY THREE DOLLARS (\$286,973) TO THE ANCHORAGE FIRE SERVICE AREA CAPITAL IMPROVEMENT PROGRAM FUND (431) FOR COMMUNICATION, TECHNOLOGY, OR OTHER CAPITAL IMPROVEMENTS
