AN ORDINANCE ADOPTING AND APPROPRIATING FUNDS FOR THE 2000 ENTERPRISE  
ACTIVITIES/MUNICIPAL UTILITIES OPERATING AND CAPITAL BUDGETS  
FOR THE MUNICIPALITY OF ANCHORAGE

WHEREAS, the Mayor has presented a recommended 2000 Enterprise  
Activities/Municipal Utilities Operating Budget and Capital Improvement Budgets for the  
Municipality of Anchorage to the Assembly in accordance with Article XIII of the Municipal Charter;  
and

WHEREAS, the Assembly reviewed the budgets as presented; and

WHEREAS, on November 9 and November 16, 1999 duly advertised public  
hearings were held in accordance with Article XIII, Section 13.04 of the Municipal Charter; and

WHEREAS, the 2000 funds are now ready for appropriation by ordinance

NOW, THEREFORE, the Assembly hereby ordains:

Section 1. That the 2000 Enterprise Activities/Municipal Utilities Operating and  
Capital Improvement Budgets are hereby adopted.
